Thematic parallel session specification (Friday morning)

1. **Brainstorming on the high-impact LAND4FLOOD paper topics leaded** *by Pavel Raska and Nejc Bezac*

Activity description: In case that you are interested in the collaboration on a high-quality crossdisciplinary paper you are warmly invited to this break-out session. The main idea is to use existing LAND4FLOOD network to gather enough information from various disciplines and different countries in order to prepare a high-quality paper that will be submitted to one of the high-impact journals. In general, the paper should bring together our current efforts using a cross-country evidence and presenting clearly defined directions for further research. In order to prepare a paper outline your contributions are needed. As a starting point, we will use some ideas from the preliminary discussions and open questions. The focus of this activity will be to narrow down a state-of-the-art scientific question that will be investigated in the scope of the LAND4FLOOD network. After the scientific question will be defined, we will define the methodological framework and main tasks that need to be carried out in order to gather relevant data. All contributors to this activity will be considered as co-authors in case that paper will actually be written, submitted and published.

2. Discussion of contribution(s) to Water journal special issue on Flood Risk Governance for More Resilience *by Piotr Marczak and Dries Hegger*

Activity description: A presentation, a poster, and a group discussion on a paper (papers) to be submitted to "Flood Risk Governance for More Resilience" in the journal Water. The aim of the activity is to identify suitable topics for papers – in line with the aim and scope of the special issue – that could be written within the Land4Flood network. The intended outcome of the meeting is to elaborate on at least one suitable topic for an internationally comparative paper. A discussion is to lead to establishing an agenda of writing the paper.

Regarding the Land4Flood contribution, we have the following overall theme in mind: It is increasingly argued that private actors should become more involved in flood risk governance. Literature on private sector involvement (including roles of businesses, NGOs, citizens) is highly dispersed, however, and a systematic overview of which private actors participate, where and why is lacking. Moreover, the distinction between private and public sector differs among countries and so does the attribution of responsibilities to public and private actors. A potential aim of the paper is to present a typology of actors and forms of non-public actors involvement and to present examples from different countries.

3. Discussion: The feasibility of low cost management of pluvial floods through the cooperation of farmers by Andras Kis and Gabor Ungvari

Activity description: Within a European context pluvial floods on flat agricultural land generally happen during late winter and early spring when the soil is already saturated with water and evaporation is still low due to low temperatures. Pluvial floods can create substantial damage to farmers. The usual response is canalisation of the agricultural area and transfer of excess water away from the fields. This is an expensive technology as it requires investment and maintenance of the canal system and machinery and energy to transfer the water and it goes against the principles of integrated water management.

An alternative approach is to collect excess water locally and store it in lower lying land segments. Land owners of the latter, less attractive pieces of land can offer water storage, nutrient assimilation as a paid service to neighbouring farms. The cooperation of numerous farms can result in a local market of water accumulation and storage. The co-operation can result in other services that originate from the water driven diversification of the "agricultural" landscape (e.g. reed management, forestry). Within the group we would like to discuss

- if actual examples for such cooperation exist and what experience they generated
- how the cooperation of farmers can be catalysed by experts ("land use brokers")
- how the Common Agricultural Policy (CAP) helps or hinders the realisation of such local solutions
- specifically, how the Ecological Focus Area requirement of CAP could be utilised to this end.

The discussion may result in deeper knowledge exchange among participants with the focus on join project proposals or/and publications.

Flood Resilience Game Experience (Friday afternoon)

The Flood Resilience Game is set in an area exposed to seasonal floods. Players take on the roles of community members (workers, farmers, entrepreneurs, financial services agents), local government and water board officials. The direct interactions between players create a rich experience that can be discussed, analysed and lead to concrete conclusions and actions. This allows players to explore vulnerabilities and capacities leading to an advanced understanding of interdependencies and the potential for working together.
